



Private Lessons

Prices effective for current month only.

As of September 1st, 2018, registration fees for private lessons apply to all non-registered gymnasts, and a new registration form will need to be filled out by parents/guardians for the current gym year.

Initial all Private Lesson Policies:

Annual Registration fee of \$15 is required for private lessons (this does not apply if student is already registered at AIM for the current gym year). **Registration fees are non-refundable.** A current waiver/registration form must be filled out by parents/guardians every current gym year. All parents/guardians of students are required to have a current phone number, address, and email address on file. **Gymnasts have to sign-in at AIM office, in Private Lesson binder prior to private lesson. Be sure to include gymnast first and last name, time frame, and coach's name.**

Lesson times are set up between the gymnast and the individual coach. We will give you the name and number of the coach and the two parties are responsible for communication with lesson times, cancellations, rescheduling, etc.

Cancellation Policy: You need to inform your coach 48 hours in advance when cancelling. If you don't show up more than 3 times in a row without notifying the coach, you will lose your spot and it will be given to the next person on the private lesson waiting list. If a coach bills us for their time and the gymnast did not take a lesson or did not cancel 48 hours in advance, you will be billed a \$25 no-show fee. If you show up for a scheduled lesson and the coach does not, the same coach will give a free lesson. Keep each other's phone numbers handy and keep the lines of communication open! Some cancellations and schedule changes are going to happen, as long as both parties are aware, billing should not be a problem.

Dress Code: For all **gym** classes: A.I.M policy recommends gymnastic leotards. Tight fitting tank tops, t-shirts, or shorts are all ok. **Sports bras as tops are prohibited, mid-section of body must be covered.** Hair must be up. Jewelry, jeans, shoes, socks, tights, or loose-fitting clothes are all prohibited. **Please take time to learn more about Safe Sport by following link:**

Billing Policy: Billing is the responsibility of AIM, not private lesson coach. Coaches bill AIM for their gym time, we pay the coach, and then bill the student. This is done during each pay period; therefore, you will be billed about a month after the private lesson has happened. Make sure to contact the office for your statement if you do not receive it! Updated Auto Pay Information MUST be on file.

Small group private lesson prices are based on 3 gymnasts. **Large group private lessons** are based on 4 or 5 gymnasts. If a gymnast in the group does not come, the rest of the group will be charged for a semi-private or private lesson. If this happens, make sure to tell the coach if you want to continue the lesson. It is recommended with a group of 6 or more students, you talk to the coach about scheduling a consistent class or session.

Late Fee policy: A late fee of \$25 will be applied, 30 days after private lesson bills are mailed out if payment is not received. Statements are mailed for private lessons and 30 days delinquent accounts. Accounts 60 days delinquent, child will **NOT** be permitted to participate until payments are made. After 90 days delinquent, there will be a 12% delinquent fee added to account balance each month. Payment arrangements will need to be made, or we will proceed to collections.

You may sign up for one lesson or however many is wanted. Usually gymnasts will attend lessons until a skill is learned. Please communicate when you are requesting a lesson with the office on the desired skills and time frame you are thinking. Lessons will be given on the available equipment and gym available at the time of the lesson.

Drop-off and Pick-up policy: Supervision will not be available outside of the private lesson scheduled. Please do not leave your child unattended until their lesson starts. **No child is to be left alone with their coach** during a private lesson. If a private lesson is scheduled during non-gym hours, it is **YOUR** responsibility to insure there is an adult in care of your child. If you drop off your child early or pick them up late there is a \$10 fee for every 15 minutes.

Viewing area policy: **No photography** is allowed! All non-registered AIM participants must remain in the viewing area at all times. Only students & instructors are allowed on the floor. Parents **MUST** supervise all children not participating in class. If non-participating children are being disruptive to classes, we may ask you to leave the viewing area. If you need to speak to your child, please notify the office. Do not talk to your registered child during class.

We are not responsible for any lost or stolen items left in the gym. You can always check AIM's lost and found for lost items.
